Birth certificates will be issued to the owner for documentation for the registration application when the calf reaches 3 years of age or for use with a transfer application if the calf is sold prior to 3 years of age.

Birth recording for non-members is a double fee which is \$50.00. Enclose fee with application. Recording of birth does not guarantee registration. Animals at 3 years of age must still meet IMZA standards.

BIRTHS OUT OF NON-REGISTERED PARENTS ARE NOT ELIGIBLE FOR RECORDING.

### ADDITIONAL REQUIREMENTS:

TWO CLEAR CLOSE UP COLORED PHOTOS TAKEN FROM ONE SIDE OF THE CALF WITH THE MOTHER. NO POLAROID. CAMERAS SHOULD BE HELD 18" to 24" above the ground. Digital photos may be e-mailed to AMJA&R office.
